Notice is hereby given that the Dahlonega City Council will hold regular Council meetings the first Monday of each month at 6:00 p.m. with the exception of the months of January and September. The January Regular Council meeting will be Tuesday, January 3, 2017 at 6:00 p.m. The September Regular Council Meeting will be September 6, 2017 at 6:00 p.m. The regular meeting dates for 2017 are **Tuesday, January 3, 2017**; Monday February 6, 2017; Monday, March 6, 2017; Monday April 3, 2017; Monday May 1, 2017; Monday, June 5, 2017; **Monday, July 11, 2017**; Monday August 7, 2017; **Tuesday, September 5, 2017**; Monday October 2, 2017; Monday November 6, 2017 and Monday December 4, 2017.

The regular council meetings are open public meetings and will have a designated time for public comments.

The Dahlonega City Council will hold work session meetings on the third Thursday of each month at 4:00 p.m. The work session meetings are open public meetings, however there will be no designated time for public comment.
