AN ORDINANCE TO AMEND ORDINANCE 2080-10-95 TO ALLOW FOR ADDITIONAL ENFORCEMENT BY NORTH GEORGIA COLLEGE AND STATE UNIVERSITY PUBLIC SAFETY OFFICERS UPON ANY PROPERTY UNDER THE JURISDICTION OF THE BOARD OF REGENTS OF THE UNIVERSITY SYSTEM OF GEORGIA OR UPON ANY PROPERTY WITHIN 500 YARDS OF ANY PROPERTY UNDER THE JURISDICTION OF THE BOARD OF REGENTS OF THE UNIVERSITY SYSTEM OF GEORGIA LOCATED WITHIN THE CITY LIMITS OF THE CITY OF DAHLONEGA

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DAHLONEGA THAT ORDINANCE 2080-10-95 IS HEREBY AMENDED AND RESTATED IN ITS ENTIRETY AS FOLLOWS:

WHEREAS, pursuant to Sections 40-6-181 & 183 and 20-3-72 of the Official Code of Georgia Annotated concerning alteration of speed limits by local authorities, the following ordinance regulating speed limits within the City of Dahlonega is hereby adopted.

BE IT RESOLVED by the City Council of Dahlonega that the following speed zones are established based upon a Traffic Engineering Investigation as required by Georgia law; and

BE IT FURTHER RESOLVED, that this is a legal and binding document and any unauthorized changes will cause this Ordinance to be VOID in its entirety. This includes the removal, installation, and/or relocation of signs erected on State Right of Way or any written changes made to this Speed Zone Ordinance; and

BE IT FURTHER RESOLVED, that it is unlawful to use radar detection devices on any State route, county road or city street not listed on this ordinance; and

BE IT FURTHER RESOLVED, that this Ordinance includes any legally posted speed limits before, during or after any construction/work zones on any city street or state route; and

BE IT FURTHER RESOLVED, that any person convicted of a violation of this ordinance can be punished to the maximum as provided by Georgia Law; and


BE IT FURTHER RESOLVED, that the City of Dahlonega agrees to allow the Lumpkin County Sheriff's Office to enforce the zones established in this Ordinance; and

BE IT FURTHER RESOLVED, that the City of Dahlonega agrees to allow the North Georgia College and State University Public Safety Office to enforce any zones established in this Ordinance that lie within the jurisdiction of the Board of Regents of the University System of Georgia or that lie within 500 yards of any property under the jurisdiction of the Board of Regents of the University System of Georgia within the City of Dahlonega.


ALL ORDINANCES or parts of Ordinances in conflict with this document are hereby repealed.
